

Corporate Fire Walk T&C's for registration on website

These conditions have been put in place to ensure all participants remain safe throughout the event:

- You must register in advance of this event by Thursday 10 October – you cannot enter on the night.
- Places are limited and will be allocated on a 'first come, first served' basis. The Chilterns MS Centre reserves the right to change the registration closing date, or close registration, at any time.
- I understand that if I am booking more than one participant place, I am agreeing to the terms and conditions on behalf of everyone.
- I understand that my registration fee is not refundable and that my place is not transferable without prior consent from Chilterns MS Centre.
- I agree to raise a minimum sponsorship of £100 and all sponsorship must be paid to the Chilterns MS Centre by Friday 8 November 2019.
- I understand that I must be 18 years or older and I understand that I must follow instructions on the day from officials and the event's organisers.
- I understand the fire walk is completely voluntary and entirely at my own risk.
- I understand that the Chilterns MS Centre will process my personal data for the purpose of my event application, and that they will never sell or swap my details with anyone. I understand that confidentiality will be retained on the Chilterns MS Centre's database for safety reasons, and that this information will not be shared with anyone other than the medical provider at the event. - I understand that the Chilterns MS Centre cannot be held liable for any changes made to the event for safety reasons, or as otherwise planned, through circumstances beyond our control; this includes indirect, punitive, special, incidental or consequential losses connected with any aspect of this event.
- I understand that Chilterns MS Centre reserves the right to cancel this event at any time if necessary due to unforeseen circumstances.
- I understand that I must abide by the rules, instructions and regulations I receive prior to the event and any instructions displayed or given to me on the day of the event by officials.
- I understand that any person who is, in the opinion of the trainer, unfit to participate will NOT be permitted to take part.
- I agree to assume full responsibility for any injury or injuries, physical, mental or otherwise that I may sustain by participating.
- I understand that no assurance guaranteeing my safety is being made and I agree to hold UK Firewalk, Chilterns MS Centre, the facilitators, organisers and property owners completely exempt of all Liability if I sustain any injuries and I am aware that Chilterns MS Centre, their employees and volunteers cannot be held responsible for any personal injury, accident, loss, damage or public liability.
- I understand that my clothes could get dirty from the ash and my footwear must be easy to remove. Nail varnish and toe rings are fine.

- I understand that I am able to withdraw from the fire walk at any time and that I understand I should withdraw if I feel unwell or uncertain about whether I can continue with my challenge.
- I understand that I should be well hydrated (drink plenty of water).
- I understand that if I am tired, stressed or recovering from illness I will be less focused and have an increased risk of receiving a blister.
- I understand that my feet must be clean and free from massage and pedicure oils.
- I understand that I must not be under the influence of alcohol or illegal recreational drugs whilst taking part in the event.
- I understand that I need to take safety precautions, including, but not limited to wearing appropriate clothing and footwear.
- I understand that there will be professional photographers and filmmakers capturing the event. The film and photographs of the event may be used in future Chilterns MS Centre publications, online and in the media, and to help publicise Firewalk for the Chilterns MS Centre in the future.
